Installation Requirements

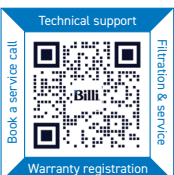


Installation Notes

- Electrical** A standard 15 amp power outlet is required, located no further than 1000mm from the underbench unit. The system is supplied with a 1 metre flex cord and plug.
- Water** A single 1/2" BSP (15mm) stop-tap with a male thread should be installed in an easily accessible position. Water supply must be microbiologically safe to drink, with a minimum dynamic water pressure of 250kPa and a maximum of 1000kPa.
- Pressure Valve** Integrated 500kPa pressure limiting and dual check valve is pre-installed to the unit inlet.
- Stone Benches** Billi has a no-cut policy regarding all stone benches in compliance with regulations. The safety of our team and customers remains Billi's top priority.
- Ventilation** No joinery ventilation or accessories are required for this Billi product (water cooled technology).
